  - Enable users to benefit from the expertise of professional trading teams through copy trading.

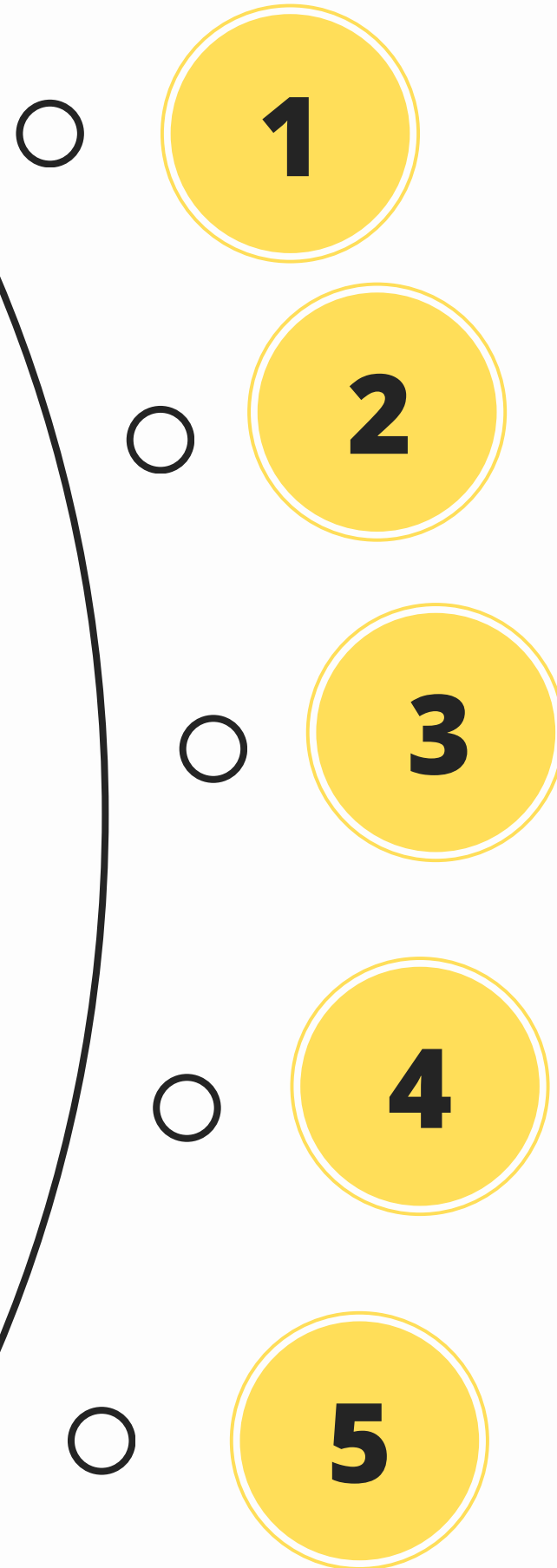
## Problem 4

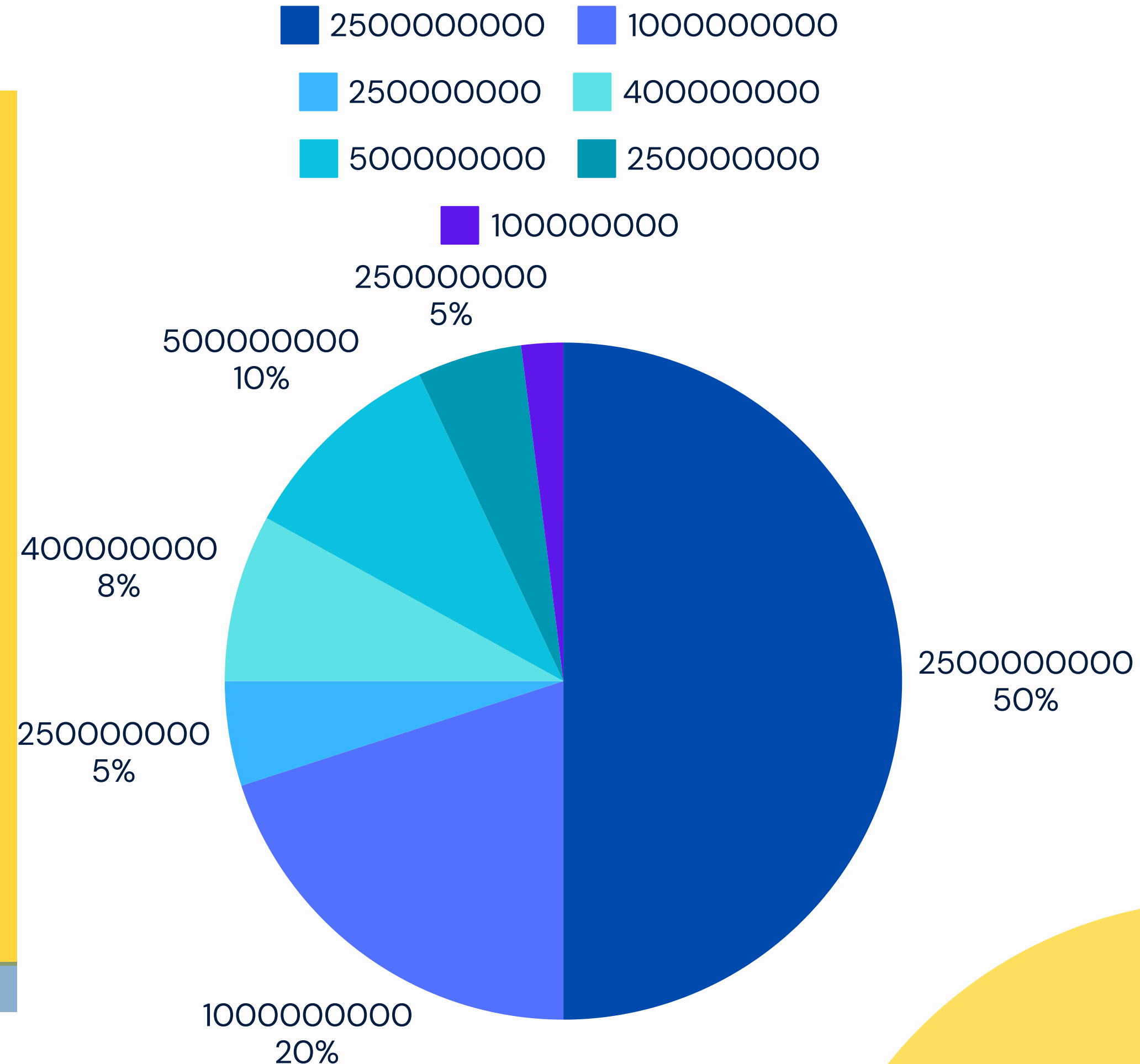
